Information on the procedure and fees of the regular sports medical evaluations

Dear Athletes!

The procedure of the regular sports medical evaluation:

The athlete books an appointment with the sports doctor's clinic belonging to the National Sports Medical Network at a pre-arranged time (online, by phone, e-mail).

If the evaluations are requested at an external location for a group of athletes, the sports club books the on-site examination from the sports doctor.

The elements of the sports medical evaluation:

checking the completed and signed athlete's questionnaire, consultation, physical examination, blood pressure measurement, 12-lead ECG, urine test, and blood test over 35 years of age. Depending on the sport and level, other additional tests are carried out (orthopaedics, ophthalmology, neurology, laryngology).

If properly performed and validated medical results are brought along, the sports doctor can accept these results - in this case, the sports medicine examination itself carried out in the sports medical clinic, is free of charge for amateur athletes with a valid social insurance (TAJ) number.

After the examination and the assessment of suitability, the athlete's classification (fit/not fit to compete, suitable/not suitable to participate) is also recorded in the electronic system (Sports Medical Register), so that authorized sports federations can download them. In the case of a paper-based competition license, the classification is stamped in the athlete's sports document (blue book, official card, form, etc.).

The validity of the competition license can be reconfirmed and downloaded from the OSEI's website right after the electronic data entry.

Fees for regular sports medical evaluations:

If the tests are carried out by the sports doctor (ECG, urine test, eyesight), the fee for the evaluation is HUF 1,000 for amateur athletes under the age of 18, and HUF 2,000 for those over the age of 18.

If the evaluations are conducted at an external location, an additional HUF 1,000 “on-site fee” will be charged per athlete.

At the OSEI’s Karolina út center (BSC, Budapest Sports Medical Center) the evaluation is free of charge for amateur athletes with a valid social security (TAJ) number.

For professional athletes the fee for the sports medical evaluation is HUF 9,700 plus the fee of additional tests.

The sports doctor issues a receipt to individuals. Invoices are issued by the Institute as per request. The total fee for the whole team’s evaluation is invoiced to the sports club.

Revalidation and restamping of existing sports licenses is HUF 1000 per case.

Out-of-line procedure fee 5000 HUF/ athlete/case.

Physical activity performed during acute COVID-19 infection poses an increased risk of developing complications of the COVID-19 disease.

Information on the terms of the renewed "out-of-line sports medical examination" and Last Minute booking

The Last Minute booking system is available from February 1, 2023 on the OSEI website, for extra appointment options (5 athletes per day) every day from 6 a.m. till midnight for the next weekday’s consultation hours. (E.g. Monday’s extra appointments can be booked on Sunday morning. The system is not operating on Friday and Saturday as there are no consultation hours on weekends.)

- The fee for the "out-of-line" procedure is HUF 5,000/person, regardless of age, which is accepted by the athlete by selecting and confirming an “out-of-line” date.
- The additional costs of the sports medical evaluation (invalid ID card, foreign citizenship, sport weapon ownership permit, etc.) must be paid in addition to the fee for the "out-of-line" procedure.
- The "out-of-line" procedure does not mean more additional out-of-line advantages through the course of the sports medical evaluation compared to athletes arriving for normal appointments.
- According to the usual procedure, the additional tests, laboratory, or blood tests required for the evaluation of the competition license are also fully carried out in the case of the "out-of-line" procedure. We accept properly performed and validated medical results brought along if the findings are not older than 2 months.
- If, during the screening tests, any doctor finds a discrepancy that requires further consultations and the athlete's competition license cannot be issued on the same day, or the athlete is banned for other reasons, the fee for the “out-of-line” procedure will not be refunded.
